AHCA jeopardizes oral health for kids and adults

Last week, the US House of Representatives passed the American Health Care Act (AHCA), which is a bill designed to replace the Affordable Care Act or "Obamacare." The bill is now being considered by the US Senate.

Pediatric dental services are included as a part of the "essential health benefits" in the Affordable Care Act. The AHCA would not require the essential health benefits be offered in each state, which means children's dental services may not have to be covered by every state.

Over five million American adults are able to access dental coverage through Medicaid expansion, but the AHCA would phase out Medicaid expansion. Kansas has not yet expanded our Medicaid program (KanCare), but if we do expand it, over 150,000 Kansans would be able to access the preventive dental benefit offered to adults covered by KanCare.

In an op-ed from Cecile Feldman, Dean of the Rutgers School of Dental Medicine says, "Whatever the fate of healthcare, KanCare Provider Experience Survey on behalf of the Kansas Department of Health and Environment, Division of Health Care Finance. The brief survey covers a variety of provider experience questions and is designed to help ensure that the KanCare program is as responsive and provider-friendly as possible.

The survey is estimated to take approximately 5 minutes to complete. May 8, 2017 will be the first day of the survey. Providers are requested to respond to the survey by Friday, May 26, 2017. Reserve a sugary drink display

The display is free to use for up to a month, and we reimburse postage! we urge lawmakers to keep pediatric dental benefits. In fact, we would ask them to go even further by designating dental care as an 'essential' benefit for adults."

The AHCA also would switch the Medicaid program to a block grant, which means each state would receive a fixed amount of money to run its Medicaid program. This is a major departure from the current law that ensures the federal government pays at least 60% of all Medicaid claims. Switching to a block grant could mean many KanCare services are cut and that any expansion of the types of services covered would not be possible.

According to the <u>Children's Dental</u> <u>Health Project</u>, "In addition to increasing premiums and out-of-pocket costs for many Americans, the bill endangers consumer protections and could result in fewer services covered, including dental benefits for children." The bill also would allow states to opt out of guaranteeing insurance coverage for people with pre-existing conditions.



The Senate will begin considering the AHCA after it is scored by the Congressional Budget Office. Scoring is the process by which the non-partisan



office calculates the cost of the bill and its projected impact.
