Oral Health Objectives For Healthy People 2030

Healthy People identifies public health priorities to help individuals, organizations, and communities across the United States improve health and well-being. This week, the U.S. Department of Health and Human Services announced the launch of <u>Healthy People 2030</u>, which

builds on knowledge gained over the first four decades of the initiative. Healthy People 2030 includes a wide range of objectives, including oral health. The goal is to improve overall health by increasing access to oral health, including preventive services.

The oral health objectives match many of our goals at Oral Health Kansas, including reducing the proportion of children, adolescents, and adults with active or untreated decay; increasing the proportion of people with dental insurance; increasing people's access to fluoridated water, and reducing people's consumption of added sugars.

The oral health objectives cover topics including:

- Oral Conditions-General
- Adolescents
- Health Care Access and Quality
- Health Policy
- Nutrition and Healthy Eating
- Older Adults
- Preventive Care
- Public Health Infrastructure
