First Free Session is Next Week!

The first session in the 2022 Conference on Oral Health preconference sessions begins next week, Friday, October 7. This session, Public Oral Health 101, will be presented by Dr. Bonnie

Branson, RDH, PhD with the University of Arkansas Fort Smith and Dr. John O'Malley, DDS, University of Michigan.

The session will share insight about the roles of a dentist and dental hygienist in public health, how they can create a shared vision of optimal health and improve disparities in oral health, and how coalitions can make an impact on access to care. The creator of the National Oral Health Data Portal also will show participants how to explore this exciting new national data resource and how public health advocates can use it to find the data they need.

October 14: Federal Oral Health Policy

Federal policy experts from Families USA and Community Catalyst will review the current federal oral health policy issues, including Medicare and Medicaid dental coverage, and share ways Kansas advocates can get involved.

October 21: Oral Health Policy Across the Country

State oral health coalition leaders from Missouri, Maryland, and Hawaii will join policy analysts from the National Conference of State Legislatures to review the policy issues other states are tackling to improve oral health.

October 28: Advocating for policy change in Kansas

Oral Health Kansas will share our advocacy toolkit that can help dental professionals, students, public health workers, and more learn the basics of being an advocate for better oral health. A legislator will be available to describe the best ways to educate policymakers about oral health.

Preparing for end of Public Health Emergency

At the start of the COVID-19 pandemic, the federal government declared a "Public Health Emergency."

During the public health emergency, no one was removed from Medicaid eligibility in order to ensure people maintained health insurance coverage during the emergency. Anyone who was eligible for Medicaid at the start of the pandemic or has become eligible since then has not had to re-apply for the program.

The public health emergency remains in effect, but all signs are pointing to it ending or "unwinding" by mid-January 2023. The Kansas Medicaid program (KanCare) will begin conducting eligibility reviews again once the public health emergency ends. Some people's income will have changed, and that means they may lose their eligibility. The other reason people will lose eligibility will be if they cannot be contacted to determine if they are eligible. There are steps people can take now to be sure they don't lose their eligibility because they cannot be contacted.

What to do now

If you work for an organization that is a Medicaid provider or one that works with people who are enrolled in KanCare, be sure you talk with your KanCare patients/clients and **urge them to update their contact information** as quickly as they can. In particular it's important for them to update their phone numbers and email addresses.

There are a couple of easy ways for KanCare beneficiaries to update their contact information.

- 1. Visit <u>kancare.ks.gov</u>. In the bottom right corner, you can click on the red speech bubble to chat with a virtual assistant who will help change your email and phone number right away. You also can click "Address Change" at the top of that webpage. <u>Here</u> is a flier that describes the steps in English and Spanish.
- 2. Call the KanCare Clearinghouse to change your contact information. The phone number is 800-792-4884. You can press 7 to change your contact information over the phone.



Dental Benefits Available for Medicaid Consumers

This summer, we announced the new Kansas Medicaid adult dental benefits went into effect in July. Oral Health Kansas created a helpful flyer in English and Spanish explaining the dental services that are available to Medicaid enrollees. If you are unsure what your Medicaid provider covers, you can call the number on the back of your insurance card and talk to a representative.
