Kansas Needs Dental Coverage Now

Legislators are preparing to consider the state's budget, and one issue they will consider is ensuring that everyone covered by Medicaid has access to dental care. Dental care is an integral part of health care, yet Kansas adults who are enrolled in Medicaid do not have access to services like fillings and crowns.

The American Dental Association's Health Policy Institute estimates that the Kansas Medicaid program will save money in medical costs when people are able manage their chronic diseases by taking care of their oral health. Medicaid will save money by helping people avoid emergency room visits for dental pain as well.

Including dental care for adults in the Kansas Medicaid program is cost effective and will help people stay healthy and seek employment. This year offers us the best opportunity yet to include dental benefits. There are several ways you can get help make this important change in Kansas Medicaid.


