

## Finishing the Job on the Medicaid Rate Increase

Advocates have finished providing testimony to the House and Senate budget subcommittees asking for funding to finish the Medicaid dental rate increase. Over 15 individuals and organizations made their case to the two committees to ask for \$12 million to finish the rate increase that started last year.

Consumers, providers, and advocates are telling lawmakers that the rate increase that began last year is making a difference, but it was not sufficient to make it financially feasible for more dental offices to join Medicaid. Dentists want to provide care for people who have Medicaid coverage, but as small business owners, they need to be reimbursed for the cost of that care. The commitments Kansas legislators have made to the Medicaid dental program over the last few years are remarkable. Dental coverage for adults is now in place, and a meaningful rate increase is in effect. Finishing the rate increase with an additional \$12 million is the final step.

The Senate Ways and Means Subcommittee on Human Services did not make any recommendations to include new spending yet. In the coming days we will find out if the House Social Services Budget Committee will make a recommendation on the rate increase. We will keep you posted about the next steps. Community water fluoridation is the adjustment of fluoride in public drinking water to levels proven to prevent tooth decay. It has been used safely in the United States for more than 80 years and is recognized as one of the most successful public health measures in history.


