# Medicaid Expansion Plan Released

Last week Governor Laura Kelly <u>announced a Medicaid</u>
<u>expansion proposal</u> called the "Cutting Healthcare Costs for all Kansans Act" during a press conference at Holton
Community Hospital. Her announcement follows a months-


long tour of the state during which state officials visited with Kansans.

Medicaid expansion would make Medicaid coverage available to approximately 150,000 Kansans who do not have insurance coverage through their jobs or who make too little money to be able to afford private insurance. Kansas is one of only ten states that has not expanded Medicaid, and many states have had expansion in place for a decade.

The Governor's proposal is designed to have no additional cost to Kansas taxpayers. The federal government will pay 90% of the cost of expanding Medicaid, and according to the Governor's office the remaining 10% will be covered by several funding sources outside of taxpayer revenue.

The plan includes a few new policy proposals, including a work requirement with exceptions for full-time students, full-time caregivers, veterans, and people with medical conditions. County jails pay for healthcare for their inmates, but that would change under this plan by allowing inmates to be eligible for Medicaid while they are incarcerated. The Sheriffs of Sedgwick and Douglas Counties noted that including this population will cut expenses for local taxpayers and ease the burden on law enforcement.

The Governor's proposal is a compromise approach to Medicaid expansion. Oral Health Kansas supports Medicaid expansion because it will ensure more Kansans with low-income have access to life saving medical and dental care. We also support compromise as the best way to enact policies that can improve lives. Read more about Governor Kelly's proposal in this <u>background document</u> prepared by her office.
