Legislature Hits Mid-Point

Last Friday was "Turn Around Day" at the Capitol. This marks the halfway point of the 2024 legislative session and is the day by which bills needed to pass out of their chamber of origin. From now until the end of the legislative session, there will be fewer bills under consideration. Two bills we have been following moved forward last week.

HB 2453 would allow Kansas to join a new <u>national dentist and dental hygienist interstate</u> <u>compact</u> which would make it easier for dental professionals to become licensed in the state. Seven states must pass interstate compact bills in order for it to go into effect. Four states have passed it since last year, and Kansas is on the list of the states considering a bill. HB 2453 passed out of the House of Representatives with a vote of 119-0. Oral Health Kansas supports this legislation, and our testimony in favor can be found on our <u>website</u>. The next step is for the bill to go to the Senate for consideration.

<u>SB 103</u> would eliminate the "20 percent rule" in the Kansas Dental Practice Act. The "20 percent rule" in Kansas says that a dentist who owns a practice must be in the practice at least 20 percent of the time the office is open. The bill passed out of the Senate Public Health and Welfare Committee, but has not been considered by the full Senate yet. It is still alive for consideration. Oral Health Kansas submitted neutral testimony on this bill. That testimony also is on our <u>website</u>.

The Legislature will meet through the first week of April. During this time we will learn if these bills and any other legislation affecting the oral health community will pass. The House Health and Human Services Committee also has promised a hearing on Medicaid expansion before the end of March. Oral Health Kansas will submit testimony in favor of expansion.

Along with these bills, Oral Health Kansas' advocacy to include \$4.8 million in the state budget to cover dental exams, x-rays, and cleanings for adults in the Medicaid program is moving forward. Today the Senate Ways and Means Committee accepted the recommendation for this funding in their budget. The House Appropriations Committee recommended the funding be considered during the wrap-up portion of the legislative session known as Veto Session in late April. Success Begins with a Smile

Last week, Kathy Hunt, OHK Dental Program Director, delivered a presentation entitled "Success Begins with a Smile", to young individuals residing in the Wyandotte County Juvenile Detention Center in Kansas City, Kansas. Assisted by James Davis, RDH, they had lively conversations with the 24 students as well as the staff from the juvenile detention center. The presentation centered on the role good oral health plays not only in the young people's overall health, but their ability to succeed in

life.

During the session, students engaged in a hands-on activity that allowed them to observe the acidic effects that simple carbohydrates have on teeth. They were astonished and visibly impacted by the demonstration. Afterwords, staff reported that many of the students were seen looking in their own mouths and chatting about what they learned.

Guardians of Smiles: Veterans Oral Health

Across the country, more than 85% of Veteran Health Administration enrollees are not eligible for dental care coverage. A <u>white paper</u> by CareQuest Institute and the American Institute of Dental Public Health (AIDPH), shares that veterans have greater rates of tooth decay and gum

disease than their civilian peers. They're also more likely than non-veterans to have diabetes and hypertension, which dental disease can make harder and more expensive to manage.

- 8.6% of the Kansas population, or about 192,964 people, are veterans
- 14.4% of veterans live in a rural county
- Geary, Clay and Leavenworth County have the highest veteran population
