The National Council on Disability (NCD) is pleased to announce the release of a new Special Report entitled, "Incentivizing Oral Health Care Providers to Treat Patients with Intellectual and Developmental Disabilities." This groundbreaking report provides Key

Recommendations to the President, Congress, and the Department of Health and Human Services on policy changes in Medicaid and Medicare aimed at improving access, care, and oral health equity for people with intellectual and developmental disabilities (I/DD). Amged M. Soliman, Esq., Senior Attorney Advisor at the Nation Council on Disability will present the Report at the upcoming Medicaid-Medicare CHIP Services Dental Association Symposium (MSDA) on May 2nd, where a detailed discussion of the study and recommendations will take place.
