One More Step to Preventive Dental Care Funding

On Tuesday evening, the Legislature approved a budget that includes the \$4.8 million needed to cover preventive dental care for adults in the Medicaid program. Throughout this year, Oral Health Kansas and our partner have been advocating for funding for the Medicaid program to cover <u>basic preventive dental care for adults</u>.



Legislative champions from both the House and Senate worked hard to secure the funding, and many partners contacted lawmakers to stress the importance of including preventive dental care for adults, along with the fillings, crowns, periodontal care, and dentures that were added over the last two years. The next step is for Governor Kelly to sign the budget bill. Then the coverage will go into effect on July 1, 2024.

The new funding will mark a significant change in

how preventive dental care for adults is covered in Kansas. For the past decade, the Medicaid managed care organizations have been offering preventive dental care for adults, but now the preventive care will be consistent for all adults and will not change from year to year. This change will bring more predictability to consumers and providers and should increase adults' access to dental care.

Asian Americans, Native Hawaiians, and Pacific Islanders Heritage Month

May is Asian Americans, Native Hawaiians, and Pacific Islanders month. Oral health practices can vary significantly across different Asian and Pacific Islander communities, influenced by cultural traditions, dietary habits, access to dental care, and socioeconomic factors.



In some Asian cultures, traditional medicine and remedies are often utilized for oral health maintenance alongside modern dental practices. Certain cultures may have specific rituals or dietary habits that impact oral health, such as the consumption of betel nuts in some Pacific Islander communities, which can lead to oral health issues like gum disease and oral cancer.

Access to dental care can be a challenge for some Asian/Pacific American communities due to factors like language barriers, financial constraints, and lack of insurance coverage. Cultural perceptions of oral health and dentistry may also influence individuals' willingness to seek professional dental care.
