May is Asian American, Native Hawaiian, and Pacific Islander Heritage Month

The National 2023 theme for the observance of Asian American, Native Hawaiian and Pacific Islander Heritage Month (AA/NH/PI) in May is "Advancing Leaders Through Opportunity." Although we see opportunity defined as "a set

of circumstances that make it possible to do something," we also see opportunity as everyone should have access to dental care.

According to the Centers for Disease, Control and Prevention, the two leading causes of death among AA/NH/PI adults are cancer and heart disease. Cigarette smoking increases the risk of developing these two conditions. Oral health disparities are a growing concern in the AA/NH/PI populations. According to recent studies, these communities are more likely to experience oral health problems and have limited access to oral health care services.

Several factors contribute to these disparities, including language barriers, cultural differences, and lack of insurance coverage. For instance, many individuals are not proficient in English, which makes it difficult for them to communicate with healthcare providers and access appropriate oral health services. This week, join a webinar on May 11, Building Healthier Communities through Language Access: AANHPI Perspectives and Solutions and learn about creative solutions for providing language access services to diverse Asian populations in both community and healthcare settings.

Additionally, cultural beliefs and practices may impact their oral health practices, leading to untreated dental issues. Many AA/NH/PI individuals lack dental insurance, making it harder for them to afford regular check-ups and necessary dental treatments. This is a major barrier to accessing preventive care, which is crucial in maintaining good oral health.

To address these disparities, various organizations are working towards increasing awareness and access to oral health care services for AA/NH/PI populations. Dental health programs and

community outreach initiatives are being developed to provide culturally and linguistically appropriate care, while also addressing other social determinants of health that impact oral health, such as poverty and food insecurity. One example coming up on May 16, the Center for Science in the Public Interest will be having a webinar on Indigenous Communities and Food Justice Panel. Register for the webinar here.

Oral health disparities in the AA/NH/PI communities are a pressing issue that requires concerted efforts from healthcare providers, policymakers, and community members. By working together to increase awareness and access to oral health care services, we can improve the overall health and well-being of these populations.
