Adult Dental Coverage Checker Debuts

Last week CareQuest Institute hosted a webinar to introduce the new <u>Medicaid Adult Dental Coverage</u>

Checker. The goal of the interactive tool is to provide states with a clear classification system

for Medicaid adult dental benefits. The new tool was developed in partnership with the American Dental Association Health Policy Institute (ADA HPI), Center for Health Care Strategies (CHCS), National Academy for State Health Policy (NASHP), CareQuest Institute, and advisory committee members. The Checker is a tool for people to understand where each state's Medicaid adult dental benefits package falls on a continuum from no dental benefits to extensive benefits, helping them identify areas for improvement. It gives an in-depth view of the types and frequencies of services enrollees can receive. The goal is to update the Checker annually in order to share the most recent updates to each state's coverage of Medicaid adult dental services.

Oral Health Kansas Executive Director Tanya Dorf Brunner was a panelist on the webinar and shared insight about how state-level advocates can use the Checker in their advocacy work. Legislators often ask questions about how Kansas benefits compare to neighboring states, and the Checker will make it much easier to answer that question.

Coalition Sees Dental Needs in Kenya

The Shawnee County Oral Health Coalition had a special guest speaker last week. Kansas Dental Association Executive Director Kevin Robertson joined the group to share his experiences with a dental mission trip in Kenya earlier this summer. A group of Kansans participated in the trip through Missions of Hope International to provide dental care in the slums of Nairobi and in rural areas on the east cost of the African nation. Over the

course of the trip, the group was able to work with local dentists to help provide care at local schools. Some of the students had never had dental care before. Shawnee County Oral Health Coalition members enjoyed learning about the experience and shared some of their own similar experiences.



World Health Organization Releases New Global Oral Health Action Plan

Over the past two decades, the United Nations and World Health Organization (WHO) have worked with national health ministries and governments in all countries, including the United States, on high priority action areas for health improvement. This has resulted in unprecedented resource allocation and health action coordination and resulting health

improvements across many indicators. Examples include more than a 30% reduction in maternal mortality globally, a 59% reduction in child mortality, a decrease in malaria by up to 62% in priority regions, as well as marked decreases in HIV/AIDS and Tuberculosis. Last year,

at the World Health Assembly, oral health was declared a global health priority by the WHO and officially incorporated into the political agenda in May. The WHO Global Strategy on Oral Health was adopted in May this year, and the draft <u>Global Oral Health Action Plan</u> was released for an open comment period this month.
